It must content the main materials, procedures and methods used in the work. The methods that have been published, should be presented the corresponding reference.

# **RESULTS AND DISCUSSION**

The results must be clear and precise and the discussion should be centered in the relevance of the results and not have to be repeated.

Tables will be inserted in the text in the body of the work. They will be consecutively numbered with Roman numbers and the title centered above them with initial capital letter.




Fig. 1 Figure example
